 BY THE DESIGNATED LICENSED DRIVER, WHO IS A MINIMUM OF 21 YEARS OF AGE,
 AS PER YOUR HIGH TIDE CARTS CONTRACT AND GLYNN COUNTY ORDINANCE \$2 15-67.
- THIS VEHICLE SHALL NOT BE REMOVED OR DRIVEN ANYWHERE OTHER THAN SAINT SIMON'S ISLAND, GA or SEA ISLAND, GA ON/IN COMPLYING ROADWAYS OR COMMUNITIES. CARTS RENTED ON SEA ISLAND MUST REMAIN ON SEA ISLAND, AS SEA ISLAND CAUSEWAY HAS A 45 MPH SPEED LIMIT.
